I was checking the manuals and the report of the authentication of the e-books.

Concerning the e-book that I coordinated (Food Safety Management Systems) there is only one reference with a level of similarity that is high (24%). The majority of the others are very low (1% or less). This higher similarity is in the 1st section concerning EU legislation where it is specifically commented the legislation and we were using sentences identical to text of the legislation. The reference to all the legislation is always very clear related to each point that is address.

Regarding the Quality Management Tools and Quality Management Systems I was expecting a certain level of similarity in the sense that this are very well established subjects an text to describe and discuss the subjects cannot vary too much. I think the important is that the authors did not copy directly existing documents and references are properly made when information from other sources are used. If this is done and I do not see any problem on these manuals. Obviously it is important that authors (and their institutions) assume the responsibility for the text they are writing in the e-books,

I have been allocated to review the text of th Quality Management Tools e-book that CRE.THI.DEV coordinated.

The Quality Management Tools e-book is well written presenting very clearly the key ideas of the tools presented. Some minor remarks are listed below. Parto of them are minor questions related with format and a couple are suggestions for improvement.

LIST OF REMARKS:

To refer the bibliography in the text with the name of the author(s) and date in brackets – e.g. (author name, date)

I tis missing the number and legend for the figure in page no. 13. The other figures consequently need to be renumbered.

The tables and figures are not number as proposed: sequential by chapter and not sequencial for all the book (e.g. Figure 9 should be Figure 3.1).

Some examples in figureasand tables are not the most adequate, namely: Figure 9, exemple in page 42 (Tables 5 and 6 and Figure 11) and exemple in page 45 (Table 7 and Figure 13) are not the most adequate: can be change to something more related with the food industry?

In page the bibliographic reference i tis not in the proper format .

In page 58, in the baking exemple, time and temperature in the oven are two diferente factors. The levels are two temperatures (minimum and maximum) for temperature and two times (minimum and maximum) for time.

In the exemple in page 61 consider to use 450 ml instead as 450 g because the units more appropriate for volume/bottles are ml.

Figures (or tables) should be original even if similar to those publishedin other books. In that case it should be putted a remark on the bottom of the figure (or tables) a remark such as: “adapted from (nome of the author, date)” and list this in the bibliography.

Not all the references in the “Bibliography” are identified in the main body of the texto, in the chapters.
